DATA PROTECTION NOTICE

This website is owned and managed by Platikistan, a to-be-incorporated crypto service provider whose leaders are based in Bavaria, Germany. It is essentially meant for information purposes. Further details shall be provided after incorporation.

PERSONAL DATA PROCESSED

This website does not process any personal data, since it does not collect any information, neither does it use cookies nor tracking technology. However, on our social media profiles (Twitter, Telegram and Discord), we process personal data such as your likes, comments, and profile information, by simply viewing and at times reacting to your contributions, without taking any further action. This is information that you voluntarily make public. Please visit the privacy notices of the respective social media service providers for information on how they process personal data. Kindly note that most of the data we process is purely anonymous, as it is the case with most decentralized crypto services. Nevertheless, in situations where we process personal data, we do so in accordance with the GDPR.

DATA PROTECTION PRINCIPLES

Whenever personal data is processed, it is done in accordance with the following principles:

- **Lawfulness:** the personal information is only processed if such processing is authorized by law; that is why we base such processing on either your consent or our legitimate interests;
- **Fairness and transparency:** your personal information shall not be processed in a manner that would be detrimental to you or exceed your expectations. We would provide you with the necessary information on how we process your personal data;
- **Purpose limitation:** your personal data is processed only for the specified, explicit and legitimate purposes for which it was collected, except where further processing is judged compatible with the initial purposes, for instance, for the establishment or exercise of legal claims;
- **Storage limitation:** your data is stored only as long as it is necessary to achieve the intended purpose, after which it shall be automatically deleted;
- **Data minimization:** your data is quantitatively and qualitatively reduced to only what is strictly necessary, to achieve the intended purpose;

- **Accuracy:** your personal data shall be kept up to date;
- **Integrity and confidentiality:** your personal data is processed in a manner that ensures appropriate security, including protection against unauthorized or unlawful processing and against accidental loss, destruction or damage, using appropriate technical or organizational measure; and
- **Accountability:** we do document all the measures taken while processing your personal data, to be able to demonstrate to the German data protection supervisory authorities that we are GDPR compliant.

YOUR RIGHTS

As a data subject, you have the following rights:

- The right to receive information regarding your personal data and to obtain a copy of such data;
- The right to rectify your personal data that is in our keeping;
- The right to request the deletion of such data;
- The right to restrict the processing of your personal data;
- The right to object to a processing operation that is based on our legitimate interest, or withdraw consent, where applicable;
- The right not to be subject to a decision based solely on automated processing, including profiling, which produces legal effects concerning you or similarly significantly affects you; and
- The right to complain with the supervisory authority,
