# PEOPLE'S DEMOCRATIC REPUBLIC OF **PLATIKISTAN**

## CONSTITUTION

9<sup>th</sup> September 2025

### Preamble

The People's Democratic Republic of Platikistan (PDRP) is a micronation in Europe whose sole mission is to make the world a better place. Platikistan shall abide by all internationally recognized rules and promote universal values and best practices, unless a given rule, value, or practice is deemed incompatible with this constitution.

The leaders of Platikistan are those who have pledged to always act in good faith and take into account the fundamental rights and interests of the citizens. Each member of the Government must hold a reasonable amount of President PLATY token, demonstrate enough integrity and humility, and be committed to pursuing sustainable benefits, rather than immediate ones. They shall not interfere in the political affairs of other sovereign states, be it in words or in deeds, at least not in their official capacities.

Platikistan shall not claim any territory of any sovereign State. However, nothing prevents it from acquiring its land or territories, in accordance with the applicable laws.

President PLATY (PLATY) token is the official currency of the People's Republic of Platikistan, and the Platikian Government is responsible for ensuring its sustainable appreciation and survival.

## **Section A: Form of the state**

### **Article 1**

The *People's Democratic Republic of Platikistan* (PDRP) is the official name of the nation of Platikistan. It shall equally be permissible to refer to it as Platikistan, or simply PLATY. The PDRP is a constitutional tyranny, headed by the eternal President PLATY. While its establishments could be located in different parts of the world, Platikistan shall remain a centralized unitary state with PLATY City as its capital. The Prime Minister must ensure the survival of the Nation and its PLATY token.

### **Article 2**

The currency, nation, major rivers, lakes, mountains, and distinctive features of Platikistan must always derive their names from President PLATY, whose sole mission is to serve the interests of the people of Platikistan. The citizens shall be referred to as Platikians (singular: Platikian).

### **Article 3**

*One World-One People-One Dream* is the motto of Platikistan, and the above flag and emblem are the official symbols of Platikistan. Other symbols, such as an anthem and a slogan, shall be adopted by the Government and be modified whenever the need arises.

### **Article 4**

English is the official language of Platikistan. All the other languages of the world are the nation's working languages.

### **Article 5**

Love and Humanity are the official religions of Platikistan. However, each Platikian is free to adhere to other religious movements, on condition that this does not become a topic for debate in Platikistan.

### **Article 6**

Platikistan shall be neutral regarding all political and internal affairs of other nations. It shall never take sides or support any foreign political movement against another. However, each Platikian is free to belong to any peaceful political movement if he or she may so desire. In that case, he or she shall be acting as an individual, and not on behalf of Platikistan. Affiliation to any form of extremism, once established, shall result in automatic dismissal from the Government and/or the loss of Platikian citizenship.

### **Article 7**

The Government shall ensure that the official website and social media accounts of Platikistan remain active, current, and meet generally acceptable standards. This shall equally apply to any physical addresses of Platikistan.

## Section B: The Government

### Section B.1. The Executive

#### Article 8

Platikistan shall always be under the rulership of President PLATY, whose official name is *His Excellency President **PLATY**, Field Marshal, Lord of all the Beasts of the Earth and Fishes of the Sea, Supreme Leader, and the Eternal President of Platikistan*. He equally has all the good titles of this world. The Prime Minister of Platikistan shall always represent President PLATY.

#### Article 9

The Executive shall constitute the following administrative bodies:

- a. The Government Headquarters and Office of the Prime Minister
- b. The Sovereign Ministry of Foreign Relations, Trade, and Win-Win Partnerships
- c. The Sovereign Ministry of Law, Fairness and Uprightness
- d. The Sovereign Ministry of Wealth, Money and Financial Freedom
- e. The Sovereign Ministry of Knowledge, Development, and Technology
- f. The Sovereign Ministry of Awareness, Transparency, and Marketing
- g. The Sovereign Ministry of Enjoyment, Relaxation, and Fun

The competence of each of these ministries is defined in the following articles.

#### Article 10

The **Government Headquarters and Office of the Prime Minister** shall be responsible for the day-to-day administration of Platikistan, in accordance with the instructions of President PLATY. It shall be headed by an *Honorary Prime Minister and Custodian of the PLATY token*, whose designation shall be carried out by the highest holders of the PLATY token, on behalf of President PLATY.

- a. The Prime Minister shall have the powers to appoint, promote, and dismiss other government officials (including ministers and ambassadors), approve budgets, and supervise the activities of all the other ministries. In consultation with the top PLATY holders, he may decide to give Platikistan a new orientation, and create new ministries or dissolve or restructure existing ones.
- b. The Prime Minister shall incarnate the core values of Platikistan, and for the purposes of stability, may retain his position as long as he receives the support of the top holders of PLATY.
- c. As Custodian of the PLATY token, the Prime Minister shall have a final say in all matters relating to the token. He shall ensure that each decision reflects the supreme interests of Platikistan and the legitimate aspirations of its noble citizens.

- d. Nothing in this present constitution prevents the Prime Minister from holding other posts of responsibility.

#### Article 11

The **Sovereign Ministry of Foreign Relations, Trade, and Win-Win Partnerships** shall be responsible for all relations with the outside world, be they of a business or diplomatic nature. The Ministry shall conclude agreements on behalf of Platikistan, in close collaboration with the Prime Minister.

#### Article 12

The **Sovereign Ministry of Law, Fairness, and Uprightness** shall be responsible for enforcing this constitution and other relevant instruments, and promoting the rule of law in Platikistan. It shall ensure that the Government complies with all its legal and moral obligations, while guaranteeing the citizens' right to justice. The Ministry shall take legal measures, especially peaceful ones, to protect the Government against any national or foreign threats. It is responsible for resolving disputes between other ministerial departments, and in case of any escalations, the Prime Minister shall have the final say.

#### Article 13

To ensure the appreciation and survival of the PLATY token and improve the lives of the citizens, the **Sovereign Ministry of Wealth, Money, and Financial Freedom** shall plan, manage, and oversee the use of all government-controlled assets. It shall advise the Prime Minister and all other authorities on financial matters.

#### Article 14

The **Sovereign Ministry of Knowledge, Development, and Technology** shall be responsible for promoting education and the advancement of technology in Platikistan and shall cooperate with foreign entities to achieve its objectives. In this regard, it may grant scholarships to both nationals and non-nationals of Platikistan.

#### Article 15

The **Sovereign Ministry of Awareness, Transparency, and Marketing** shall be responsible for communication in Platikistan. It shall take measures to bring Platikistan and its PLATY Token to the attention of the world. It shall publicize Government actions and achievements in Platikistan and beyond.

#### Article 16

The **Sovereign Ministry of Enjoyment, Relaxation, and Fun** shall be responsible for ensuring leisure in Platikistan and abroad, including the promotion of tourism, social events, and other forms of celebrations. It shall manage the recreational facilities of Platikistan.

## Article 17

Each Ministry shall be headed by an Honorary Minister, and the scope of its duties can be extended by the Prime Minister through an administrative act. Although an honorary position, the Prime Minister may allocate allowances for each minister, in close collaboration with the Sovereign Ministry of Wealth, Money, and Financial Freedom.

## Article 18

For internal convenience, ministers may reorganize their ministerial department into smaller units and appoint the leaders of each unit, in close collaboration with the Prime Minister.

## Article 19

Each ministry shall cooperate with all other administrative bodies of Platikistan to ensure the smooth functioning of the Government. Two or more ministries may mutualize their efforts to achieve specific goals. Each minister shall be answerable to the Prime Minister.

### ***Section B.2. The Legislative***

## Article 20

The citizens of Platikistan all act as Members of Parliament, and must be consulted on specific matters concerning their Nation. However, the Prime Minister and his or her Government retain the powers to adopt any acts that they judge appropriate and are in the supreme interest of Platikistan.

### ***Section B.3. The Judiciary***

## Article 21

In conformity with Article 10 of this Constitution, the Sovereign Ministry of Law, Fairness and Uprightness shall exercise judicial powers.

## ***Section C: Other elements of statehood***

### **Section C.1. Population**

## Article 22

All holders of the PLATY token are automatically recognized as citizens of Platikistan. However, to become a noble citizen with the right to vote and enjoy other benefits and privileges, one must hold a reasonable amount of PLATY over a certain period. The amount of PLATY and the required period shall be determined by the Sovereign Ministry of Wealth, Money, and Financial Freedom, taking into account the price and other circumstances. Irrespective of the amount of PLATY held, the Prime Minister may exceptionally confer citizenship on a given individual who has significantly contributed to the development of Platikistan. He may equally decide to revoke Platikian citizenship from anyone in case of gross misconduct, especially involving a serious violation of the present constitution.

## ***Section C.2. Land***

### **Article 23**

Platikistan shall not make any unlawful territorial claims in any part of the world. However, the Government may acquire a piece or pieces of land in any sovereign country, which would host Platikian institutions and facilities, and accept payments in PLATY.

### **Article 24**

The Government shall acquire and manage a limited amount of virtual lands, especially in the form of non-fungible tokens (NFTs), for the people of Platikistan. The lands must be tradable.

### **Article 25**

The Government must ensure that it remains the highest holder of Platikian lands, and must take measures to give them adequate utility.

## ***Section C.3. Currency and finances***

### **Article 26**

President PLATY (PLATY), a Cronos token, shall remain the official currency of Platikistan, and has a total supply of 1,000,000,000 tokens. While burns are not excluded, any increase in supply is and shall remain impossible and prohibited. Any proposal to modify its name is inadmissible and shall be considered an act of rebellion.

### **Article 27**

The Government must ensure that it remains the highest holder of the PLATY token, especially by providing for untouchable reserves that must be jealously kept for a given period. After the expiration of said period, the reserves shall be repartitioned, without omitting new reserve allocations.

The exact amount of PLATY individually held by the Government shall be made public, and must be managed in a manner that ensures the survival of the token and the nation, while ensuring that it remains the highest holder.

### **Article 28**

The Government must take all necessary measures to ensure progressive and sustainable appreciation of the PLATY token, including giving it some utility and concluding profitable partnership agreements.

### **Article 29**

The Government must act appropriately to stabilize the price of PLATY, including the allocation of funds for buybacks during bear markets. A reasonable amount of PLATY shall equally be allocated for marketing, to bring the token to the attention of the world.

### Article 30

A reasonable amount of PLATY shall equally be allocated to back the PLATY virtual lands. Profits made from the lands shall be declared and allocated appropriately.

### Article 31

Some amount of PLATY may be allocated for donations. The citizens shall be informed each time a particular sum is donated, with information on the purposes of the donation, and where appropriate, the identity of the beneficiary. Where a large amount of PLATY is donated, the Government shall conclude agreements with the beneficiary to ensure that the amount is not sold in a manner that would significantly affect the price of the token.

A small amount shall equally be allocated for committed volunteers.

### Article 32

The Government shall allocate a specific amount of PLATY for trade and investment, especially in foreign projects. Profit made from such ventures shall be declared and allocated appropriately.

### Article 33

All Platikian assets managed by the Government must be done transparently and responsibly, and whenever appropriate, with the direct participation of Platikians who have the right to vote.

### Article 34

Each Platikian has the right to question the manner in which state funds are used, and the Government is required to provide appropriate answers.

### Article 35

The Government must make it possible for those who mismanage funds or are involved in financial crimes to be brought to book.

## ***Section C.4. Army***

### Article 36

Each citizen is a soldier, and shall be solicited to take action whenever the Nation is attacked, or whenever the Government intends to disseminate information. Depending on the circumstance, each citizen is equally required to defend Platikistan and all its interests, even without an express request from the Government. Such action must be civilized, proportionate, and well coordinated, taking into account the rights and freedoms of non-citizens of Platikistan.

- a. The possession and use of arms of any nature is prohibited.
- b. Each Platikian is required to act responsibly, be the incarnation of humility and moral rectitude, and refrain from any acts of violence.



- c. Attacks and threats of a serious nature are to be immediately brought to the attention of the Government.

### ***Section C.5. International Sovereignty***

#### Article 37

The Government shall establish diplomatic relations with other micronations, friendly entities, and peoples of the world. The ambassadors and diplomats appointed by the Prime Minister shall be coordinated by the Sovereign Ministry of Foreign Relations, Trade, and Win-Win Partnerships.

### ***Section D: Main prohibitions***

#### Article 38

The following is prohibited in Platikistan:

- a. **presidential elections:** our eternal President PLATY is irreplaceable, and elections would be a waste of resources.
- b. **inactivity of the Government:** the Government is not allowed to spend up to three months without addressing the citizens, irrespective of whether there are any major developments or not. A communiqué from any of the relevant Ministers would suffice.
- c. **incompatible discussions:** such as those on sensitive topics, such as but not limited to religion and wars.
- d. **dumping:** selling a large amount of PLATY by a Member of Government or a noble citizen in a manner that would seriously affect the price.
- e. **violation of privacy:** the disclosure of the identity (personal data) or assets of any Platikian without the latter's explicit consent.
- f. **abuse of position:** using Platikian platforms and contacts to pursue personal interests, such as advertising products that would not benefit Platikians or promoting foreign interests.
- g. **illegality:** any act that violates this constitution or the laws of any sovereign nation.
- h. false claims, acts of sabotage, misinformation, misrepresentations, and any activity that might be prejudicial to the PDRP, its PLATY token or its citizens.
- i. bullying, discrimination, and any form of attack against any individual.

The Sovereign Ministry of Law, Fairness, and Uprightness of Platikistan shall take appropriate action against defaulters.



## Section E: Miscellaneous provisions

### Article 39

This constitution shall enter into force once duly signed by the Prime Minister. It shall be published on our official website and channels, as well as external journals.

### Article 40

Any amendments to this constitution must be approved by the Prime Minister.
